

Rush Lake Kennels, LLC Health Guarantee and Bill of Sale

This agreement is between Rush Lake Kennels, LLC (seller) and _____ (buyer).

Rush Lake Kennels will not knowingly sell a sick puppy. We back up that policy with the guarantee that if you return your puppy within 7 days of purchase with a written statement from your veterinarian that the puppy has a serious health problem, you will be given a complete refund of the purchase price of your puppy.

In addition to the 7-day guarantee, Rush Lake Kennels offers a conditional guarantee against ocular/vision defects and hip/elbow dysplasia. Rush Lake Kennels takes every measure to not knowingly breed lines that have a predisposition for ocular/vision defects or dysplasia problems. All of our stud dogs and brood matrons are OFA certified (hips/elbows) and eye certified. Obesity, poor nutrition and injury can contribute as much to the development of dysplasia as can genetic factors.

To be covered by the conditional health guarantee:

- The dog must be AKC registered in the original purchaser's name
- The dog must not have been sold
- The dog must not be more than 26 months old
- The dog must not have been bred or used as a sire

If you suspect either eye or dysplasia problems, please follow this procedure:

1. Notify us either by phone or in writing
2. Send us either (a) copies of X-Rays & OFA certificate OR (b) EYE certificate
3. Send us a written statement from your veterinarian that includes
 - a. Diagnosis of ocular/vision defect or dysplasia
 - b. Description of dogs general health including notation of dogs weight
 - c. Proof of vaccinations including rabies, adult combination and Bordetella
4. Send us a front and side photo of the dog
5. Send us proof of spaying or neutering signed by a veterinarian
6. Send us the dog's AKC registration certificate

All information will be reviewed with Rush Lake Kennels' veterinarian. If the dog covered by this guarantee is found to have ocular/vision defects or dysplasia and the buyer has followed all of the above requirements, Rush Lake Kennels will either (A) provide a replacement puppy out of a comparable breeding **or** (B) refund the purchase price. If requesting a replacement puppy, the selection of the replacement puppy is at the discretion of Rush Lake Kennels. Any transportation costs for a replacement puppy are the responsibility of the buyer. Regardless of the option selected, Rush Lake Kennels will not require the return of the original dog.

The puppy must be registered with the AKC within six months of purchase and the registered name must begin with "RLK" to identify Rush Lake Kennels.
